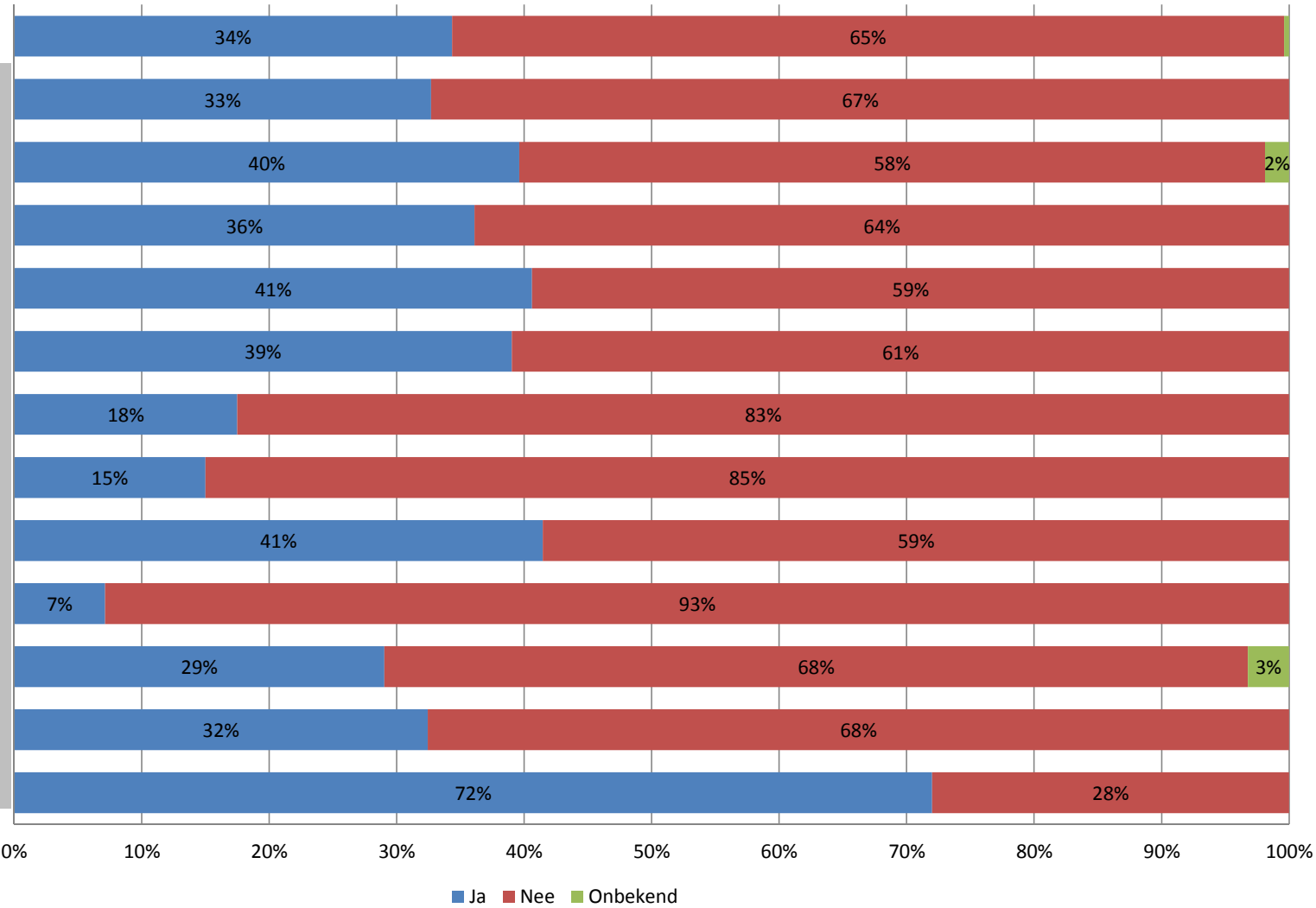


1-meting: voorberekingsformulier in GPS



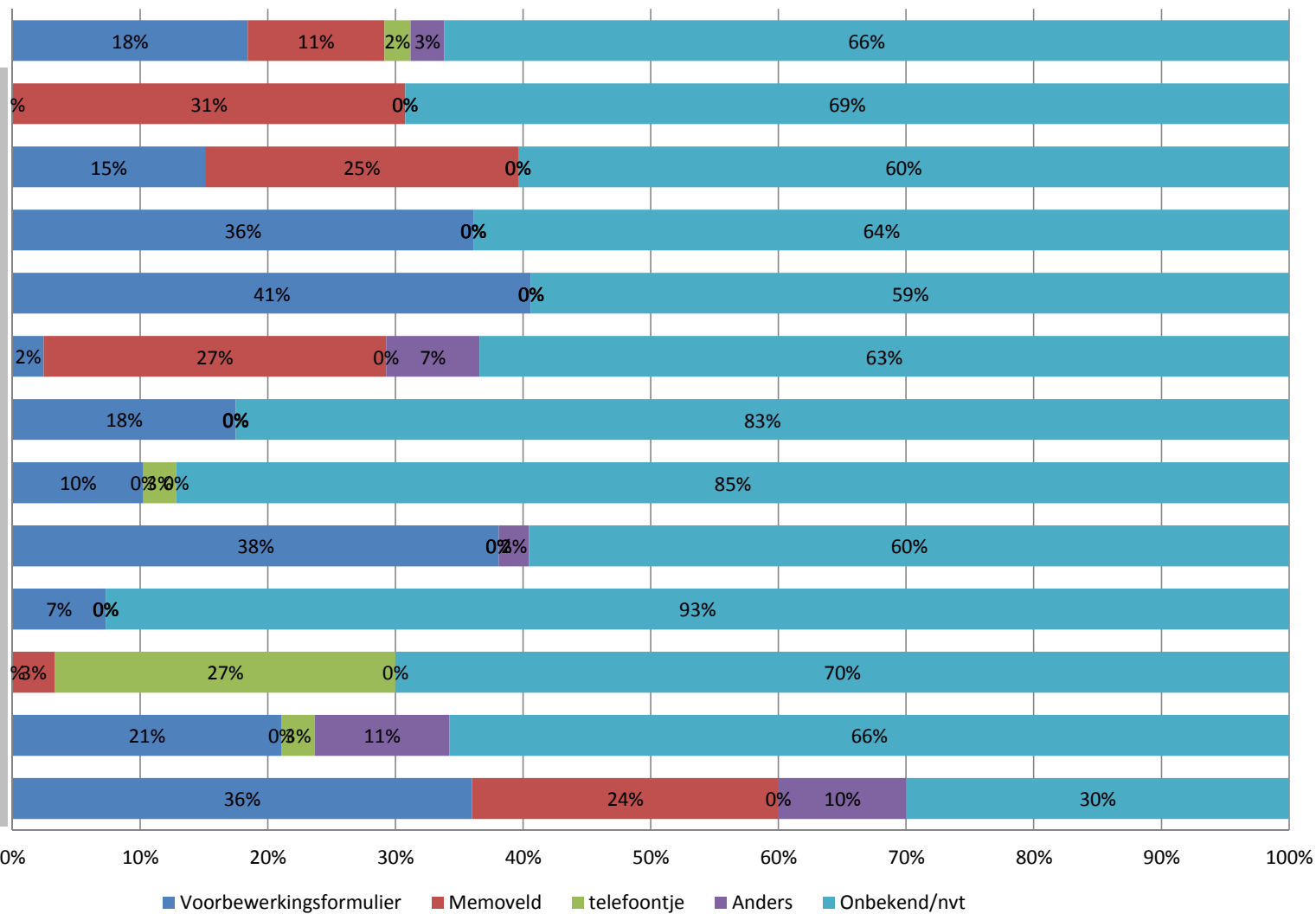

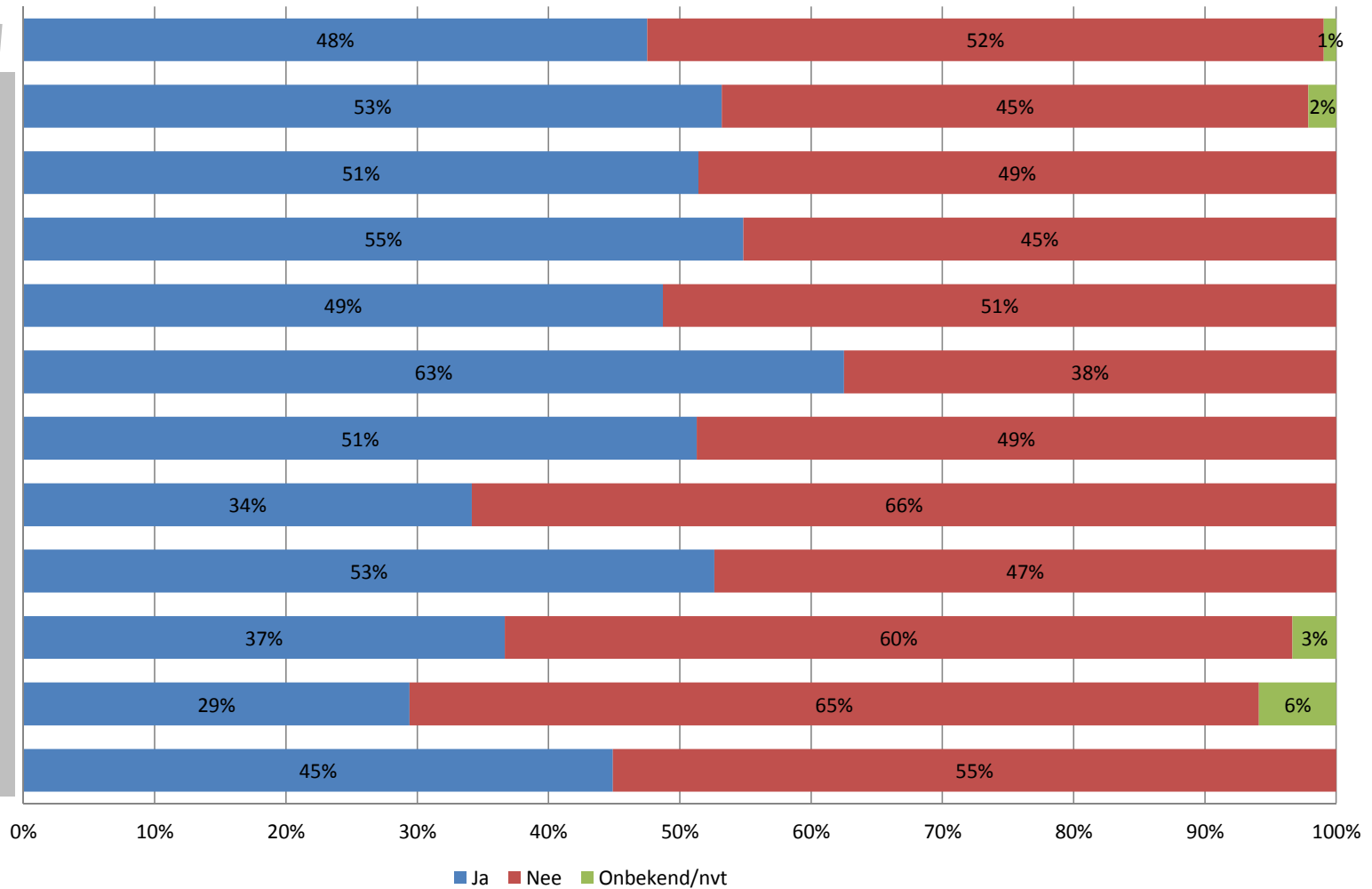


1-meting: Strafmaat gemotiveerd bij afwijking van richtlijn

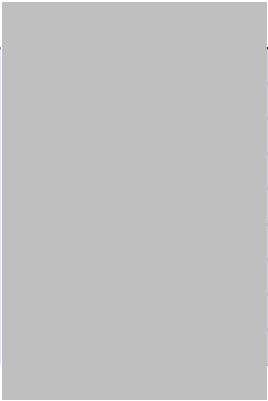

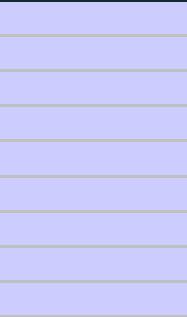
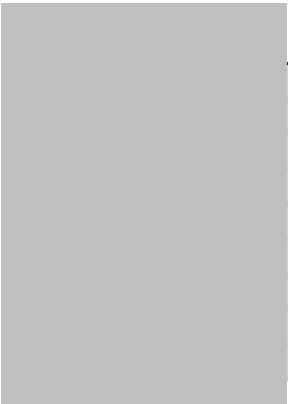
