Het Kaderbesluit 2004/68/JBZ van de Raad van de Europese Unie van 22 December 2003 ter bestrijding van seksuele uitbuiting en kinderpornografie (inwerkingtreding 2004).

Art. 1:

Definitions

For the purposes of this framework Decision:

(...)

(b) "child pornography" shall mean pornographic material that visually depicts or represents:

(i) a real child involved or engaged in sexually explicit conduct, including lascivious exhibition of the genitals or the pubic area of a child; or

(ii) a real person appearing to be a child involved or engaged in the conduct mentioned in (i); or

(iii) realistic images of a non-existent child involved or engaged in the conduct mentioned in (i);

Het Facultatief Protocol in zake de verkoop van kinderen, kinderprostitutie en kinderpornografie (inwerkingtreding 2005)

Art. 2c:

Child pornography means any representation, by whatever means, of a child engaged in real or simulated explicit sexual activities or any representation of the sexual parts of a child for primarily sexual purposes."

Het Cybercrime verdrag (inwerkingtreding 2006)

Art. 9, lid 2:

2. For the purpose of paragraph 1 above, the term "child pornography" shall include pornographic material that visually depicts:

(...)

c) realistic images representing a minor engaged in sexually explicit conduct.

Het Verdrag van de Raad van Europa inzake de bescherming van kinderen tegen seksuele uitbuiting en seksueel misbruik (inwerkingtreding 2009).

Art 20 lid 2: For the purpose of the present article, the term "child pornography" shall mean any material that visually depicts a child engaged in real or simulated sexually explicit conduct or any depiction of a child's sexual organs for primarily sexual purposes.
